Parents and service providers worked in groups to answer....


SEN Support/EHCP

Communication/general comments:

- Parents and child's voice must be heard supported and valued.
- Transport should be discussed at annual reviews particularly the year of and year before transfer.
- Transitions need to be structured and planned
- Need health to input
- Secondary schools not getting support right.
- Poor communication does not help
- Need info on what schools should provide and do Schools talk about funding not need – What is your first port of call for queries? – Need good communication.
- Schools are ignoring child's needs and ignoring reports and advise given
- Professiojnal need to see child (Indepth) to offer advise, can't rely on other people's understanding, it could be incorrect.
- School staff need to recognise parents concerns and talk to them as equals and be honest

- If needs are not met, things can get worse
- NQTs need support
- Professionals need to show and demonstrate they are 'experts' to build trust
- Schools should recognise that SEN causes behaviour, they are not naughty
- Look at the child's self esteem and levels of anxiety
- Stop blaming resources for not meeting child's needs.
- Experience of A,P,D,R in practise but it is not fully realised though.
- Breakdown in communication with the school but hopefully parent s can pull back through the A,P,D,R process.
- School good at having meetings with parent

What would help?

- Parents need info and support to make decisions.
- Recognise that not all parents can help sort things and some need support to help their child.
- Recognising SEN and not 'Blaming' the child.
- Better transitions.
- Funding to support the 'do' of A,P,D,R
- Continuation of support from year to year
- Learning passports accessible to all, including teacher to teacher
- A differentiated report for SEND children in mainstream, seeing your child is 90% below average does nothing to improve self esteem.

EHC Plans specifically

- Need clarity over what annual review meetings should be and the procedures
- Need clarity on cross border provision.
- Need health to input
- Consider having annual reviews in the health setting to ensure their input
- Post 16 funding decisions are slow as they go to panel. This could be sped up with an individual deciding.


Local Offer

Schools information report

- Most schools have put them in place but not everyone has seen them
- Few familys or parents were asked to be involved with their creation.
- Lack of transparency on individual pupil funding
- Poor info on access to services or signposting across county borders

- Some not aware of it at all, school did not signpost to the local offer either, little info on Assess, plan, do, review
- Parents need support to have the voice and knowledge
- Needs info about A.P.D.R
- Needs to offer support to challenge decisions, how and who can help.
- Governors need local offer training, info report needs a governor page/section
- Governors need wider knowledge outside of their school.
- More info on what schools there are and what they provide

Local Offer

- 4/5 had used the site
- Sometimes the information was too much to take in, hard to process jargon.
- If a family has cross border issues which local offer do you follow?
- Keep it simple, bullet points. School support, SEN support
- Without an EHCP the path is not as clear.
- How many meetings should you generally expect in school?
- Need access to advocacy and questions to ask in meetings
- Autism local offer
- Better to navigate than Norfolk
- Add a postcode and know where the service is delivered from
